Hi Eric

You are correct that these 2 engines carry the old style coverage of 2 years from date of delivery. We show no evidence that they were ever delivered so yes, they are covered under warranty. However, we would want you to ensure the following before we would agree to cover any claims:

- Tell us how they were preserved and whether there is proof of all preservation tasks.
- Ensure that you go through the maintenance schedule to update anything that should have been done during the past 13 years.
  - We certainly would recommend new injectors.
- Potential customers must understand that there are only 5 years remaining on these engines before a major overhaul is required per time limit. A borescope of all cylinders is
- 100% necessary.

I have had Joran Krawczak help out with this information and to send over the maintenance schedule originally provided at the time these engines shipped (attached).
